**NOTICE OF JOINDER IN THE COLORADO PETROLEUM ASSOCIATION'S
MOTION TO POSTPONE HEARING DATES**

Anadarko Petroleum Corporation (“Anadarko”), Black Hills Exploration and Production, Inc. (“Black Hills”), and Pioneer Natural Resources, USA, Inc. (“Pioneer”) (collectively the “Parties”), by and through its undersigned counsel, respectfully submit the following Notice of Joinder in the Colorado Petroleum Association’s Motion to Postpone Hearing Dates Scheduled for Deliberations on September 9, 10, and 11, 2008.

As grounds for this Notice, the Parties state:

1. On September 5, 2008, the Colorado Petroleum Association (“CPA”) submitted for the Commission’s consideration a Motion to Postpone Hearing Dates Scheduled for Deliberations on September 9, 10, and 11, 2008.
2. In support of that Motion, CPA outlined documents the Commission’s Staff served on the parties to the rulemaking on September 3, September 4, and September 5, 2008. Those documents contained Staff Revisions and Recommendations to the 200-, 300-, 500-, 600-, 700-, 900-, 1000-, and 1200-Series of Draft Rules. Collectively, the September 3, September 4, and September 5 submissions contained over 400 pages of material.
3. The Parties agree with CPA that the compressed schedule for Commissioner deliberations prejudices the Parties because the Parties’ representatives will have inadequate time within which to prepare and, as a result, will not be able to efficiently and adequately inform the Commission of their concerns and observations.

WHEREFORE, for all the reasons herein and for all the reasons set forth in CPA’s Motion, the Parties hereby respectfully submit this Notice of Joinder in the Motion to Postpone the Hearing Dates Scheduled for Deliberations on September 9, 10, and 11, 2008.
