**PRELIMINARY JOINDER OF EXXON MOBIL CORPORATION,
AND EXXONMOBIL OIL CORPORATION,
TO COLORADO PETROLEUM ASSOCIATION'S REBUTTAL STATEMENT
REGARDING DRAFT RULES PUBLISHED APRIL 10, 2008 (31 Colo. Reg. 4)**

COMES NOW, Exxon Mobil Corporation and ExxonMobil Oil Corporation, (collectively "ExxonMobil"), by and through its counsel of record, Scott M. Campbell and Nick A. Swartzendruber, of Poulson, Odell & Peterson, LLC, and hereby preliminarily incorporates and adopts the positions, witness testimonies, exhibits and legal authorities presented and/or cited by the Colorado Petroleum Association ("CPA") in its Rebuttal Statement as if fully set forth herein.

ExxonMobil reserves its right to join in any other rebuttal statements filed by other parties at such time as it has had adequate time to review those rebuttal statements—most of which it will not have seen prior to being required to file its rebuttal statement. ExxonMobil further reserves its right to revise the scope of its joinder to CPA's rebuttal statement. ExxonMobil currently believes it has consolidated into CPA's filing any and all issues which it might have with the proposed rules, but given the significant time constraints, the gravity of the issues raised in this proposed rulemaking, and the volume of information being processed, ExxonMobil may need to clarify or supplement its rebuttal. Accordingly, ExxonMobil will assert its rights, if necessary, to supplement CPA's rebuttal as permitted by Commission orders, constitutional due process and/or other applicable law.


